HOW TO REACH CVM UNIVERSITY

The Charutar Vidya Mandal (CVM) University is located in Vallabh Vidyanagar, Anand, situated between Ahmedabad and Vadodara in Gujarat. Vallabh Vidyanagar is well connected by rail, with regular train services from major cities such as Mumbai and Ahmedabad. The CVM University campus is approximately 5 km from Anand Railway Station and about 12 km from Nadiad Railway Station. The university also enjoys good air connectivity, with Vadodara Airport located about 40 km away and Ahmedabad International Airport approximately 75 km from the campus. Several places of tourist interest are located nearby, including Swaminarayan Temple, Vadtal; the paternal home of Sardar Vallabhbhai Patel; Dakor Temple; Nalsarovar Bird Sanctuary; and the Amul Milk Plant. The world-famous Statue of Unity at Kevadia is located about 120 km from the university campus.


